## Reconstruction of the I-75 Interchanges at CR 240/Old Coffee Road and CR 216/Adel Quitman Road

### **Project Description**


The proposed project would reconstruct two interchanges along Interstate 75 (I-75) in Cook County, CR 240/Old Coffee Road and CR 216/Adel Quitman Road (see **Figure 1**, Project Location Map).

The interchange at CR 240/Old Coffee Road would be designed utilizing a standard diamond interchange configuration. The proposed typical section along CR 240/Old Coffee Road would consist of two 12-foot travel lanes (one lane in each direction) with a 14-foot center turn lane and 4-foot paved outside shoulders.

The CR 216/Adel Quitman Road interchange would be designed utilizing a compressed diamond interchange configuration. However, the existing northbound entrance and exit ramps would be shifted approximately 50 feet to the east and provide approximately 660 feet of spacing between ramps. The frontage road would also be shifted approximately 850 feet west of the southbound ramps. The proposed typical section along CR 216/Adel Quitman Road would consist of two 12-foot travel lanes (one lane in each direction) with a 14-foot center turn lane and 4-foot paved outside shoulders.

I-75 entrance and exit ramps at both locations would consist of one 16-foot lane, 8-foot paved outside shoulders and 4-foot paved inside shoulders.

Proposed right-of-way would be approximately 150 feet wide along both county roads. Additional right-of-way along I-75 would also be required to construct the new ramp locations both north and south of the interchanges. Total project length is approximately 2.0 miles along CR 240 and CR 216 and approximately 5.0 miles of ramp reconstruction.
