

PROJECT DESCRIPTION

I-75 Phase II Interchange Improvements NHS-0000-00(804) PI # 0000804 TURNER COUNTY

The proposed project consists of the reconstruction and widening of five interchanges lying along an approximately 11.3 mile segment of Interstate 75 (I-75) from the Tift/Turner County line to just north of State Route 159 (SR 159). The interchanges proposed for improvements include County Road 252 (CR 252)/Inaha Road, State Route 32 (SR 32)/Jefferson Davis Highway, County Road 33 (CR 33)/Bussey Road, State Route 112 (SR 112)/East Washington Avenue, and SR 159/North Street. Each would remain a diamond configuration except for the interchange at SR 159, which would be replaced with a partial cloverleaf with a loop ramp in the northeast quadrant. These interchanges would be designed to accommodate a future eight lane typical section of I-75, which is proposed in Phase III of the I-75 widening. In addition, overpasses at SR 159, SR 32, and CR 252 would be reconstructed to meet current horizontal and vertical clearance standards, sight distance requirements, and ramp spacing guidelines. The SR 32 and SR 159 overpasses would also be widened to a four-lane typical section with a raised median and rural shoulders. Reconstructing the overpass bridges would require each crossroad to be either widened or shifted from its current alignment in the vicinity of the I-75 overpass bridge and to taper back into the original alignment. The widening or shifting and taper would extend approximately 2,000-2,500 feet along each overpass crossroad on both sides of I-75. The underpass crossroads, CR 33 and SR 112, would have very little reconstruction along their length, but their ramps would be shifted further from their current locations to improve safety and operations. Finally, as a result of the proposed reconstruction at SR 159 and SR 112, Ewing Road and Peacock Road respectively would be realigned further east.
