STP-0002-00(638); P.I. No. 0002638 Eagle's Landing Parkway from Eagle's Pointe Parkway to SR42/US23 Henry County

PROJECT DESCRIPTION


The project would consist of widening of Eagle's Landing Parkway from Eagle's Pointe Parkway through the intersection with SR 42/US 23 to 700 feet east of Talon Place in Stockbridge, Henry County, Georgia. The proposed improvements would connect the six-lane divided section currently under construction at the west end of the project with a four-lane divided section under design at the east end of the project. The proposed project length is approximately 2.6 miles. The existing roadway consists of two undivided 12-foot wide travel lanes with an existing right of way width of 200 feet. The proposed project would include four 12-foot wide travel lanes with a 44-foot wide depressed median that would separate eastbound and westbound traffic. In the future, the 44-foot wide depressed median may be replaced with a 20-foot wide raised median and two additional 12-foot wide travel lanes. This project would continue the four-foot wide bike lanes, outside curb and gutter, and five-foot wide sidewalks from Eagle's Pointe Parkway to the end of the project. Left and right turn lanes and intersection improvements will be included where warranted at all intersections. All sidewalks would be constructed in compliance with Americans with Disabilities Act (ADA) requirements. Crosswalks would be striped and improved to allow for safer pedestrian access. Both the existing bridge over the Norfolk Southern Railroad and that over Pates Creek would be replaced as part of the proposed project

The alignment being considered for this project is on display at this open house. Generally, the proposed widening is symmetrical about the existing roadway. However, the proposed widening was shifted to the north of the roadway east of the intersection with Country Club Drive to reduce property impacts. West of the intersection with SR 42/US 23, the proposed widening was shifted to the north again to minimize wetland impacts on the south side of the roadway.

The "No-Build" Alternate is also being considered. This alternate would leave Eagle's Landing Parkway as a two-lane facility as it is today. No action would be taken to reconstruct Eagle's Landing Parkway under this alternate.
