Thank you for attending the Public Information Open House for NHS00-0002-00(861), P.I. # 0002861, the proposed widening and reconstruction project will begin at milepost 13.604 on S.R. 40 / East Kings Avenue from west of C.S. 481 / North and South Grove Boulevard and end at milepost 15.043 to the east of P.R. 718 / Truss Plant Road in Camden County. In this handout package you will find a project description, location map and a comment card.

As you enter the room, you will notice displays of the proposed Project. Department of Transportation (DOT) representatives, who can be identified by the nametags they are wearing, are available to answer questions. Please take this opportunity to discuss the proposed project with a DOT representative. There will be no formal presentation.

All comments will be made part of the project record. We hope you will take advantage of one of these opportunities to let the Department know your view of the proposal.

The displays will be available for review for ten days after the public information open house at the GDOT District Five Office located at 204 North Highway 301, Jesup, GA 31546 and the GDOT Area Three Office, 128 Public Safety Blvd. Brunswick, Georgia 31525. 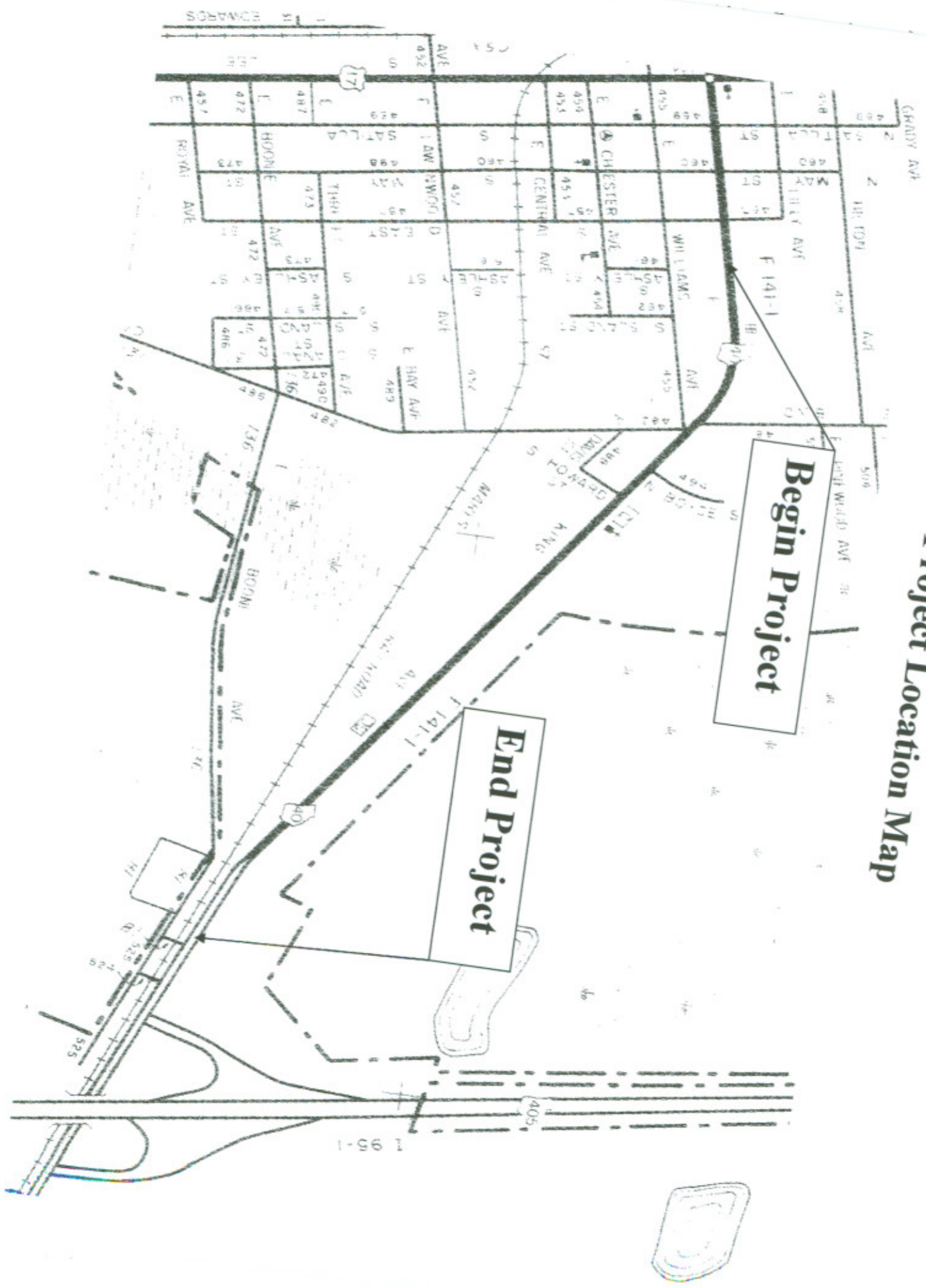

The existing section on S.R. 40 / East Kings Ave is a four lane undivided urban section. The proposed project proposes to widen and reconstruct the existing roadway from Mile Post 13.604 to Mile Post 14.881 from the four lane undivided urban section and rehabilitate the existing divided urban section from MP 14.881 to MP 15.043. The undivided urban section typical will provide for an urban 5-lane section with two 11' inside lanes, two 12' outside lanes and a 14' flush two-way left turn median and 10' urban shoulders. Five foot sidewalks are also proposed on both sides of the road. Also, an additional 4' paved section on each side will be required to accommodate bicyclists. The current posted speed is 45 mph. This segment of roadway is on the **Camden County Bicycle and Pedestrian Plan**. This segment is an integral part of a larger planned bicycle network in the Kingsland area. The divided urban section will be rehabilitated and overlaid in areas and milled and inlaid in other areas. The total project length is 1.439 miles (7,550').

The side streets at the intersection of North and South Grove Blvd will be realigned to improve the geometrics. The proposed alignment will connect and shift the alignments of both N. & S. Grove Blvd. at a 45 degree angle through the intersection of S.R. 40. The intersection of S.R. 40 / East King Ave. and N. & S. Grove Blvd will be signalized with a traffic signal for intersection traffic. Plus a **"NO RIGHT TURN ON RED"** sign will be installed as mitigation for the substandard 45 degree intersection angle for S.R. 40 eastbound. As a result, E. Williams St. will be cul-de-sac at the S. Grove Blvd. end; therefore, left and right turn movement will be prohibited.
