PROJECT DESCRIPTION

Department Project NHS-0003-00(621) involves the proposed construction of a full-diamond interchange at Three Points Road and improving Three Points Road from SR 223 to the new interchange. The existing 32.5 foot wide by 283-foot long bridge over I-20 would be replaced by a 62-foot wide by 283-foot long structure due to existing sub-standard vertical clearance. This segment of Three Points Road would become part of the existing Thomson West Bypass. The proposed location of the interchange is approximately 3 miles east of the I-20/US 78 Interchange, and approximately 3 miles west of the Warren County line. Three Points Road will be widened to provide turn lanes at the ramp intersections.

DETOUR DESCRIPTION

Three Points Road will be closed to through traffic for the duration of the project within the project limits due to the replacement of the existing bridge. Local traffic will be able to access the area from either side of I-20 but will not be able to cross over I-20.
