A copy of all comments received will be available for public review at this same location and at the Georgia Department of Transportation, Office of Environment Services, 600 West Peachtree Street NW, 16th Floor, Atlanta, Georgia 30308, as soon as compilation is completed.



PROJECT DESCRIPTION

Project HPP00-0000-00(265), Fulton County, is the addition of a multi-use path along Hardscrabble Road. The City of Roswell is sponsoring this federally funded project for the construction of a portion of the Roswell Green Loop Path. This Phase 1 portion proposes the addition of a multi-use path between King Road and Etris Road. Sidewalks, pedestrian crossings, bike lanes, and some intersection improvements will be studied, in addition to the multi-use path.
