No. 0000409, the proposed construction of a roundabout at the existing 4-way intersection of SR 16 at Old 85 Connector and Hollonville Road, in Spalding County. Click on **Public Outreach** from the **Information Center** dropdown menu at the top right side of the page, and then select **SR 16 Roundabout** in the "By Project" field. All comments will be made a part of the project record. We hope you will take advantage of one of these opportunities to let GDOT know your view of the proposal.

The displays will be available for review for ten days after the PIOH at the Georgia Department of Transportation Griffin Area Office located at 1001 Highway 19 S, Griffin, Georgia 30223. A copy of all comments received will be available for public review at this same location and at the Georgia Department of Transportation, Office of Environment Services, 600 West Peachtree Street NW, 16<sup>th</sup> Floor, Atlanta, Georgia 30308, as soon as compilation is completed.

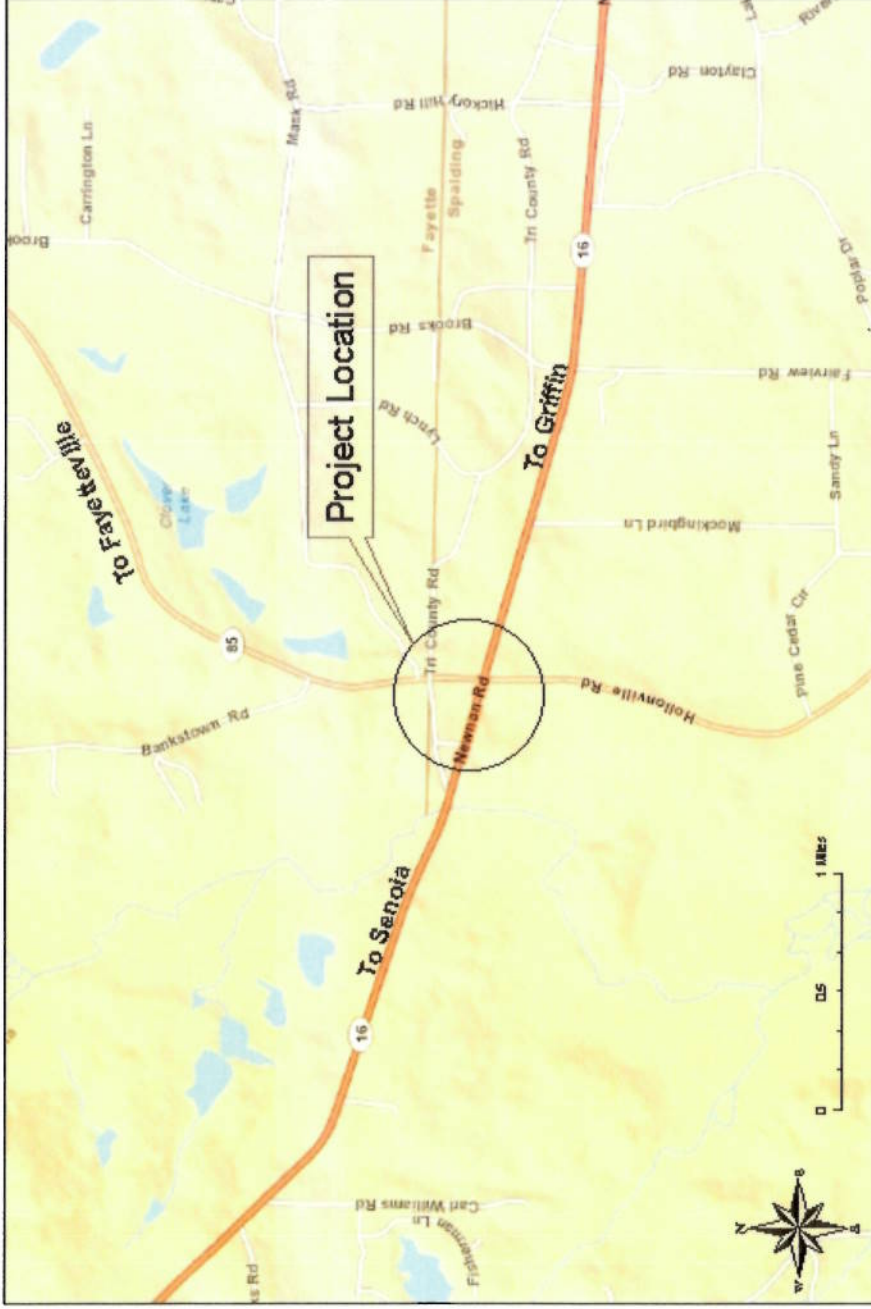

**Project Description**

Georgia Department of Transportation Project STP00-0000-00(409) proposes to construct a roundabout at the existing four-legged, two-way stop controlled intersection of SR 16 at Old 85 Connector and Hollonville Road in Spalding County. The proposed roundabout consists of transitioning the 12-foot wide lanes on each leg of the intersection to 18.5-foot wide lanes at the approach of a 20-foot wide circulatory roadway, an 18-foot wide truck apron, and a 74-foot diameter non-mountable central island. The proposed roundabout will have splitter islands, curb and gutter, and lighting on all approaches in addition to a 12-foot shoulder with sidewalk around the circulatory roadway. The length of the proposed project is approximately 0.16 mile.
