Thank you for attending the Public Information Open House for the proposed widening of State Route (SR) 30/SR 90/US 280 from Interstate-75 to Midway Road in Cordele, PI Number 0000481. Our goal is two-fold: 1) to provide you with information on the proposed project and 2) to provide an opportunity for you to give us your comments on the proposed project. In this handout package, you will find a description of the project, a location map, and a comment card.

As you enter the room, please take a look at the project display. Georgia Department of Transportation (Georgia DOT) representatives, wearing nametags, are available to discuss the project and answer your questions. There will be no formal presentation.

Your comments are important to us and, should you provide comments by one of the methods noted below, we will respond to you in writing usually within 30 days of the close of the comment period. All comments will become part of the project's official record.

While you are attending the open house, you can **provide your comments today** by filling out the comment card provided with this handout and dropping it in the comment box, or you may choose to provide your verbal comments to the court reporter who will transcribe your comments.

You can also provide your comments by Monday, September 07, 2015 by using either of the following methods:

- Online at www.dot.ga.gov/PS/Public/PublicOutreach.
 - 1. From the menu, select the county in which the proposed project is located and click Go;
 - 2. Then select SR 30/SR 90 Widening from I-75 to Midway Road;
 - 3. Lastly, click *Comment* and follow the instructions to leave your comments.

The project displays and plans will be available for review for ten days after this open house at the website noted above. Following the ten-day public comment period, a copy of all comments received will be available by request at the Atlanta address listed above.



Why We Are Here: The proposed widening project is needed to improve current and future traffic flow and congestion for cars and trucks due to the number of turning movements into commercial properties, and to reduce the frequency and severity of crashes on this segment of SR 30/SR 90/US 280.

Project Description: This project proposes to widen approximately 0.25 mile of SR 30/90/US 280 in the City of Cordele in Crisp County. The project would begin at the 1-75 northbound entrance ramps tying into the existing four-lane facility and would extend eastward to approximately 500 feet east of the intersection of SR 30/90/US 280 and Midway Road. SR 30 will be widened to provide two 12 ft. through lanes eastbound and two 12 ft. through lanes westbound with a 14 ft. flush median and 16 ft. urban shoulders. The proposed project includes adjoining side road Arc Way approximately 1000 ft. to its terminus as well as approximately 200 ft. to the North and South along Midway Road. The proposed project is expected to remain within the existing 140ft. ROW; however, additional ROW may be required at the intersection of SR 30 and Midway Road to accommodate miters and the right-turn auxiliary lanes.
