 - From the menu, select the county in which the proposed project is located and click Go;
 - Then select 133 Widening and Reconstruction;
 - Lastly, click *Comment* and follow the instructions to leave your comments.
- Mail in your comment card to Mr. Eric Duff, Georgia Department of Transportation, 600 West Peachtree Street NW, 16th Floor, Atlanta, Georgia 30308.

The project displays and plans will be available for review for ten days after this open house at the website noted above. Hardcopies will also be available at the GDOT District 4, Area 4 Office located at 120 Veterans Pkwy North, Moultrie, GA 31788 and at the GDOT District 4, Area 5 Office located at 2060 Newton Road, Albany, GA 31701. Following the ten-day public comment period, a copy of all comments received will be available by request at the Atlanta address listed above.

Why We Are Here: The State Route (SR) 133 Widening and Reconstruction project has been previously studied and GDOT most recently held a Public Information Open House (PIOH) for the project in January 2015. Comments were received from the public at that time that prompted GDOT to reevaluate the project and its proposed alignment. As a result of these efforts, additional potential environmental impacts were identified. GDOT has identified new alternatives to avoid these additional environmental resources and to address public concerns. Due to these proposed changes, GDOT is seeking public feedback on these changes to the proposed project.

Displays: The displays show the proposed alignments and the locations where proposed detours are proposed. Please note that GDOT will continue to refine the design as the project moves forward.


Project Need and Purpose: The State Route (SR) 133 corridor was identified in the 1989 Governor's Road Improvement Program (GRIP) as an area designated by the Georgia State Legislature for corridor improvements to promote rural highway connectivity, safe and efficient travel, and economic development opportunities. SR 133 is a major north-south corridor with traffic volumes ranging from 6,219 to 10,706 vehicles per day (VPD). The corridor serves a variety of uses, including the movement of agricultural goods, manufactured goods, military logistical transport, and freight transport. Given the importance of agriculture to the local economy, providing an efficient route for the movement of agricultural goods and local farm vehicles has been identified by planning studies as a critical component for stability and growth of the agricultural industries located in the region. A widespread and well-constructed transportation system linking producers with their suppliers and customers lowers overall shipping and production costs, thereby increasing farm incomes. While the corridor capacity on SR 133 appears adequate for through traffic, the long-range projections for trucks and other agricultural vehicles will lead to congested conditions. The lack of turn lanes and passing lanes for slow vehicles will create bottlenecks on SR 133 as freight movement increases. In addition, the SR 133 crash history is an indication of likely conflicts with turning or slow vehicles. The combination of rural agricultural and denser commercial areas presents challenges for drivers, especially when freight trucks or farm vehicles are involved. The lack of turn lanes presents conflicts both for turning drivers and those attempting to pass in the travel lane. The proposed capacity improvements to SR 133 would address these safety issues and support the statewide strategic plan of GDOT to reduce traffic fatalities. The construction of the SR 133 Widening and Reconstruction project would provide an improved system for the transportation of goods within southwest Georgia, improve rural connectivity, support economic growth, and provide a safer and more efficient transportation system.

Project Description: The proposed project would widen and reconstruct SR 133 through Colquitt, Worth, and Dougherty Counties between the cities of Moultrie and Albany. The proposed project would relocate some portions of SR 133 in order to minimize impacts to the project area. The project would construct two 12-foot travel lanes in each direction, separated by a 32-foot depressed median. The project has been divided into four sections as follows:

- PI No. 0000520: From 1,000 feet south of US 319 in Moultrie to 2,300 feet north of the Colquitt/Worth County line.
- PI No. 0000519: From 2,300 feet north of the Colquitt/Worth County line to approximately 1,500 feet north of SR 112 in Worth County.
- PI No.0000475: From approximately 1,500 feet north of SR 112 in Worth County to 1,700 feet north of County Line Road (CR 417/ CR 459) in Dougherty County.
- PI No.0000473: From 1, 700 feet north of County Line Road (CR 417 /CR459) in Dougherty County to 1,000 feet north of Holly Drive/South Mock Road in Albany.

The total project length is approximately 32 miles, and the proposed right-of-way would be approximately 200 feet wide.
