**Project Description**

**A. Existing**

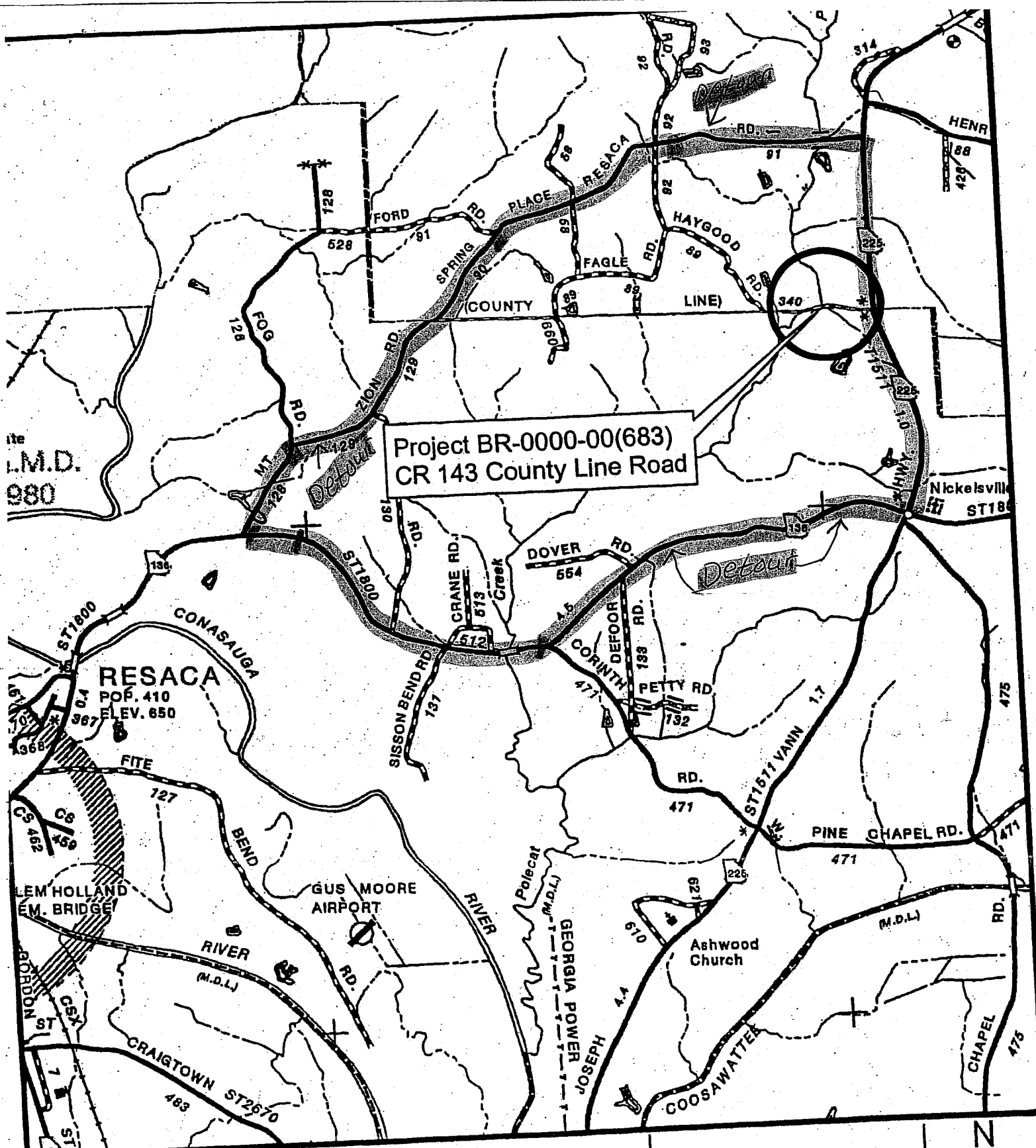
The existing typical section consists of two 7' travel lanes with rural shoulders on approximately 40' of right-of-way. The existing bridge structure is a 31' x 12.1' concrete bridge with a sufficiency rating of 38.60.

**B. Proposed**

The proposed project would replace the existing structure with a 120' x 28' concrete bridge. The proposed typical section would consist of two 12' travel lanes with 4' shoulders on approximately 160' to 180' of right-of-way. In addition, there is also a 10' easement beyond the right-of-way limits on either side of the road for most of the corridor west of the existing bridge.

**Detour Routes**

Access around the project area will be gained through the use of SR 136, Mt. Zion Road and Spring Place Resaca Road.

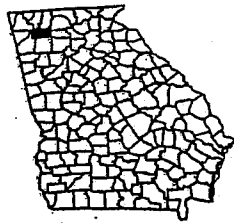
