All comments will be made a part of the project record. We hope you will take advantage of one of these opportunities to let the Department know your view of the proposal.

The displays and plans will be available for review for ten days after the public information open house at the Georgia Department of Transportation area office located at 1313 North Tibbs Road, Dalton, Georgia 30720, and at the Georgia Department of Transportation district office located at 500 Joe Frank Harris Parkway, Cartersville, Georgia 30120. A copy of all comments received will be available for public review at the district office as soon as compilation is completed.

Project Description

County Road (CR) 4/Dennis Mill Road Bridge Replacement over Rock Creek

The proposed project would replace a narrow and structurally deficient bridge on Dennis Mill Road over Rock Creek (See Project/Detour Location Map). The existing typical section consists of two 12 foot wide travel lanes with 4 foot wide rural grassed shoulders on a right-of-way width of 60 feet. The existing bridge structure is 91 feet long x 11.9 feet wide. The proposed typical section would consist of two 12 foot wide travel lanes with 5 foot wide rural grassed shoulders on a varying right-of-way width of 60 feet to 160 feet. The proposed bridge structure would be 283 feet long x 32 feet wide and would be constructed approximately 230 feet downstream of the existing structure. Traffic would be maintained by an offsite detour consisting of CR 4/Dennis Mill Road, Old Federal Road South, and US 76/SR 282. Once the project is completed, the existing bridge would be maintained as a pedestrian crossing.
