Project Description for NH00-0006-2(56) & STP00-0002-00(409) Dougherty County, PI 422560 & 0002409

The Proposed project consists of improvements in Dougherty County along 2.3 miles of Clark Avenue (SR300/SR520) from Maple Street to North Cherokee Drive. Clark Avenue currently consists of 4 - 12' travel lanes, two in each direction, and a two way left turn lane.

The proposed project would widen and reconstruct SR 300/Clark Avenue to consist of six 11 foot travel lanes (three in each direction), a 16 foot raised median, and 16-foot urban shoulders (with an additional two feet of right-of-way in order to meet a minimum 18-foot clear zone requirement for slopes). The proposed project would consist of 5 foot sidewalks on the north side and 8-foot sidewalks on the south side from the beginning of the project to the end of the project. Also, a right turn lane is proposed to be added to Turner Field Road in both directions (Northbound and Southbound).

SR3/Liberty Expressway at Clark Avenue Interchange Improvements include adding a second left-turn lane on the northbound and southbound exit ramps, extending the length of the right-turn lane on Clark Avenue at the southbound entrance ramp, adding a second right-turn lane on Clark Avenue at the northbound entrance ramp and extending the existing right turn lane, widening the northbound entrance ramp to two lanes for several hundred feet and then tapering back to one lane before merging with the expressway, and minor widening of Clark Avenue at the southbound ramps.

There are also two proposed traffic signals to be added at the intersections of Clark Avenue and the Northbound Liberty Expressway Ramps and Clark Avenue and School Street.

A maximum of approximately 195 feet of right-of-way is required for the project.
