Nos. 0003452 & 0008400, the proposed bridge replacements over Chattanooga Creek and Chattanooga Creek Overflow and CR 835/Happy Valley Road intersection improvements at SR 193. 

# Project Description BR-0003-00(452) & CSSFT-0008-00(400) Walker County PI #0003452 & PI #0008400

The proposed BR-0003-00(452)/CSSFT-0008-00(400) project would consist of the replacement of two bridges located on CR 835/Happy Valley Road over Chattanooga Creek and Chattanooga Creek Overflow approximately 4.20 miles southwest of the city of Rossville, Georgia. The existing typical section consists of two 10' travel lanes with 1' grassed shoulders on 50' of right-of-way. The existing bridge structure over Chattanooga Creek is 28' x 20'. The existing bridge structure over Chattanooga Creek Overflow is 32' x 22.3'. The proposed typical section would consist of two 12' travel lanes with 8' to 10' shoulders (2' paved and 6' to 8' grassed) on approximately 80' of right-of-way. The proposed bridge structures would be 40' x 38' over Chattanooga Creek and 60' x 38' over Chattanooga Creek Overflow. Also turn lanes would be added to the intersection of CR 835/Happy Valley Road and SR 193, allowing access from CR 835/Happry Valley Road onto northbound and southbound SR 193, and access from SR 193 onto eastbound and westbound CR 835/Happy Valley Road. Due to the removal of the existing access from Burnt Mill Lane onto CR 835/Happy Valley Road, a small cut through road approximately 88' in length would be constructed approximately 400' north of the intersection of CR 835/Happy Valley Road and SR 193 to allow access from Burnt Mill Lane onto SR 193. The section of CR 835/Happy Valley Road from approximately 200 feet east of Third Street to SR 193 would be closed during construction. Traffic would be detoured utilizing the existing Chattanooga Valley Road, SR 2 and SR 193. Project CSSFT-0008-00(400) would consist of the signalization of the intersection of SR 193 and CR 835/Happy Valley Road.
