If full implementation of the approved plan does not provide for effective erosion control, additional erosion and sediment control measures shall be implemented to control or treat the sediment source. "
51-001	Y	49. Clearly note the statement in bold letters - " Any disturbed area left exposed for a period greater than 14 days shall be stabilized with mulch or temporary seeding. "
52-ALL	Y	50. Provide detailed drawings for all structural practices. Specifications must, at a minimum, meet the guidelines set forth in the Manual for Erosion and Sediment Control in Georgia.
