



FULL SECTION AT EDGE BEAM
LOOKING UPSTATION * TWO - M27 Ø SWEDGED BOLTS




CONSTRUCTION SEQUENCE
LOOKING UPSTATION

- ** - PHASE I TEMP. CONSTRUCTION BARRIER LOCATION
 - *** - PHASE II TEMP. CONSTRUCTION BARRIER LOCATION
1. PLACE STRIPED DRUMS AT PHASE I LOCATION, MAINTAINING ONE 3800 mm TRAVEL LANE ON BRIDGE.
 2. REMOVE PARTS OF EXISTING BRIDGE, BUILD PHASE I ACCORDING TO THE PLANS.
 3. RELOCATE STRIPED DRUMS TO PHASE II LOCATION, MAINTAINING ONE 3800 mm TRAVEL LANE ON BRIDGE.
 4. REMOVE PARTS OF EXISTING BRIDGE, BUILD PHASE II ACCORDING TO THE PLANS.
 5. REMOVE STRIPED DRUMS AND OPEN COMPLETED BRIDGE TO TRAFFIC.



SECTION A-A THRU EDGE BEAM @ BENTS 1 & 5

- NOTES: EXISTING DECK, AND CURB REINFORCEMENT TO REMAIN. REINFORCING STEEL DAMAGED BY CONTRACTOR SHALL BE REPLACED AT NO COST TO THE DEPARTMENT. REMOVE ALL PORTIONS OF ARMORED JOINT AT END BENTS. COST SHALL BE INCLUDED IN THE OVERALL BID SUBMITTED.
- ⊕ PORTION OF DECK, BACKWALL, CURB, AND EDGE BEAM TO BE REMOVED AND REPLACED AS SHOWN.
 - ⊕⊕ REQUIRED VERTICAL 25 mm SAW CUT. CARE SHALL BE EXERCISED SO THAT THE EXISTING REINFORCING STEEL IS NOT DAMAGED.
