

WORK ORDER DESCRIPTION:

AN OVERHEAD/SUBSURFACE UTILITY ENGINEERING INVESTIGATION (SUE) WAS PERFORMED AND COMPLETED BY TBE GROUP, INC. ON 04/29/09 FOR THIS PROJECT. UNITED CONSULTING PERFORMED AND COMPLETED ADDITIONAL SUE INVESTIGATIONS AND UPDATED THE INFORMATION SHOWN ON THESE PLANS ON 10/21/2011. THE EXISTING OVERHEAD AND UNDERGROUND FACILITIES SHOWN HEREON WERE INCLUDED IN THESE SUE INVESTIGATION. THE PRESENCE OF THESE UTILITY FACILITIES HAVE BEEN THOROUGHLY INVESTIGATED AND THE METHOD OF DETERMINING THEIR LOCATION IS INDICATED AS SHOWN IN THE PLANS. UTILITIES THAT HAVE BEEN INSTALLED AFTER THE DATE ABOVE HAVE NOT BEEN INCLUDED IN THIS INVESTIGATION AND SHOULD BE CONSIDERED AS FROM RECORD DRAWING ONLY. ALL OTHER EXISTING TOPOGRAPHIC FEATURES DEPICTED HEREON HAVE BEEN REFERENCED FROM A TOPOGRAPHIC/MAPPING SURVEY AND CONTROL PACKAGE PROVIDED BY GDOT WITH THE DESIGN-BUILD PACKAGE. SOME OF THE FILES RECEIVED WERE MICROSTATION V8 FILES AND HAD TO BE CONVERTED TO VERSION 7.
