

**Location of Project in Fayette County** 

### Project Description STP-0000-00(399), Fayette County P.I. 0000399

The proposed project is located on State Route 92 in Fayette County. The project consists of realigning County Road 375 (Kingswood Drive) and/or County Road 553 (Hilo Road) to intersect State Route 92 to create a 4-way intersection and adding right and left turn lanes on State Route 92 and Hilo Road at the new intersection. The widening on State Route 92 will occur on both sides of the existing roadway. The installation of a stop and go traffic signal is recommended at this location based on findings presented in the Traffic Signal Warrant Analysis.

The existing right-of-way along State Route 92 is 100 feet wide. The proposed right-of-way will vary depending on which alternate is chosen.

#### **Alternates**

Alternate 1: This alternate relocates Hilo Road north to connect with the existing entrance into the Kingswood subdivision. There is no S-curve in this alternate due to coming off a tangent of Hilo Road farther east. There are at least nine (9) properties effected by this alternate with five (5) of the properties being possible total parcel acquisitions. The remaining four (4) properties will be provided a road with cul-de-sacs and access to Hilo Road.

<u>Alternate 2:</u> This alternate shifts Hilo Road slightly south and adds new access to Kingswood subdivision with a new entrance avoiding the house on the corner of Derby Drive. The existing Kingswood entrance will be removed.

Alternate 3: This alternate relocates Hilo Road north to connect with the existing entrance into the Kingswood subdivision. This differs from Alternate one (1) by adding an S-curve with a slow design speed to reduce the amount right-of-way acquisition. At least two (2) properties will be possible total parcel acquisitions. The profile of the road was also lowered to provide better site distance which caused the right-of-way to be extended.

<u>Alternate 4:</u> This alternate leaves Hilo Road where it is currently located and adds new access to Kingswood subdivision with a new entrance connecting to Derby Drive. This differs from Alternate (2) by putting in an S-curve to avoid the house on the corner of Derby Drive. The existing Kingswood entrance will be removed. The profile of the road was also lowered to provide better site distance which caused the Right of Way to be extended.
