Thank you for attending the public information open house for the proposed widening and reconstruction of State Route 133 in Colquitt, Worth and Dougherty Counties. The proposed improvements include Georgia Department of Transportation Projects STP-0000-00(520) in Colquitt and Worth Counties, STP-0000-00(519) in Worth County, STP-0000-00(475) in Worth and Dougherty Counties, and STP-0000-00(473) in Dougherty County. In this handout package you will find a project description, need and purpose, location map and comment form.

As you enter the room, you will notice displays of the proposed project. Department of Transportation (DOT) representatives, who can be identified by the name tags they are wearing, are available to discuss the project and answer your questions. Click on **Public Outreach** from the list of Featured Links. All comments will be made a part of the project record. We hope you will take advantage of one of these opportunities to let the Department know your view of the proposal.

The displays and plans will be available for review for ten days after the public information open house at the Georgia Department of Transportation District Four Office located at 710 West 2nd Street, Tifton, Georgia 31793-7510 and the Georgia Department of Transportation District Four Area Offices located at 2060 Newton Road, Albany, Georgia 31701 and 120 Veterans Parkway N., Moultrie, Georgia 31788. A copy of all comments received will be available for public review at these same locations and at the Office of Environment/Location, 3993 Aviation Circle, Atlanta, as soon as compilation is completed.
