Thank you for attending the Detour Open House for the proposed CR 321/Taliaferro Springs at Chattooga River bridge replacement, PI Number 0003081. Our goal is two-fold: 1) to provide you with information on the proposed project and 2) to provide an opportunity for you to give us your comments on the proposed project, which includes a traffic detour route that would be used during construction. In this handout package, you will find a description of the project, a location map, a map of the proposed detour, and a comment card.

As you enter the room, please take a look at the project display and the detour map. Georgia Department of Transportation (Georgia DOT) representatives, wearing nametags, are available to discuss the project and answer your questions. There will be no formal presentation.

We hope you will take the opportunity to tell Georgia DOT what you think. Listed below are several ways to comment on the project. Your comments are important to us and, should you provide comments by one of the methods noted below, we will respond to you in writing usually within 30 days of the close of the comment period. All comments will become part of the project's official record.

While you are attending the open house, you can **provide your comments today** by filling out the comment card provided with this handout and dropping it in the comment box, or you may choose to provide your verbal comments to the court reporter who will transcribe your comments.

You can also provide your comments by Wednesday, November 02, 2016 by using any of the following methods:

 - 1. From the menu, select the county in which the proposed project is located and click Go;
 - 2. Then select PI No. 0003081 CR 321/Taliaferro Springs at Chattooga River;
 - 3. Lastly, click *Comment* and follow the instructions to leave your comments.



Why We Are Here: The CR 321/Taliaferro Springs bridge over the Chattooga River project area has been previously studied and GDOT most recently held a Public Detour Open House (PDOH) in 2009. No comments were received from the public at that time; however, due to the length of time since then, the Department decided that additional public outreach would be necessary before proceeding forward once again. GDOT is seeking public feedback on the proposed detour and to gage public support for the project as a whole.

Project Description: The project proposes to construct a new 480-foot by 28-foot concrete bridge with two 11-foot travel lanes and two 3-foot shoulders. The proposed bridge would replace the existing bridge in its current location. Both bridge approaches would also be straightened. The proposed approaches are two 11-foot lanes with 6-foot rural shoulders (two feet of which is paved). The proposed bridge would consist of two 11-foot lanes with 3-foot shoulders. The proposed right-of-way (ROW) would vary from 95 feet to 142 feet. An off-site detour is proposed for the project. The proposed detour for this project runs through Lyerly Dam Road and Starling Mill Road. The detour would add approximately five minutes of additional travel time for roadway users and would be in place for 18 months. The total project length is approximately 0.61 mile.
