

PROJECT DESCRIPTION

Preferred Alternative

The proposed project (see Figure 1, Project Location Map) would reconstruct the existing interchange at Interstate 75 (I-75) and County Road (CR) 418—Omega-Eldorado Road (Exit 55) in Tift County. This project is a part of the Georgia Department of Transportation's (DOT) overall objective to increase the number of travel lanes on I-75 from 4 lanes to a minimum of 6 lanes throughout the state. The reconstruction would include replacing the existing approximately 216-foot, two-lane bridge at this interchange with a new bridge; relocating the exit and entrance ramps at this interchange; and improving Omega-Eldorado Road from U.S. 41 west approximately 2,600 feet. The new bridge at this interchange would be an approximately 300-foot, three-lane bridge to accommodate one travel lane in each direction and a center left-turn lane for the I-75 entrance ramps. The new bridge would correct sight distance deficiencies and allow for the future widening of I-75. The exit and entrance ramps would be relocated to achieve 1,000 feet of separation between ramp termini to allow for improved sight distance over the bridge and at the ramp intersections. In addition, designated right-turn lanes would be provided along the I-75 exit ramps. Improvements to Omega-Eldorado Road along the approaches to the I-75 interchange would include the provision of designated right-turn lanes onto the I-75 entrance ramps.

Additional right-of way would be required to implement this project. Existing right-of way along Omega-Eldorado Road varies from approximately 80 feet to 160 feet. The proposed right-of-way would be a minimum of 100 feet.
