

The displays and plans will be available for review for ten days after the public information open house at the Georgia Department of Transportation's District 6, Area 3 office located at 1313 North Tibbs Road, Dalton, Georgia 30720. A copy of all comments received will be available for public review at this same location and at the Department's District 6 Office located at 500 Joe Frank Harris Parkway, Cartersville, GA 30120-0010, as soon as compilation is completed.

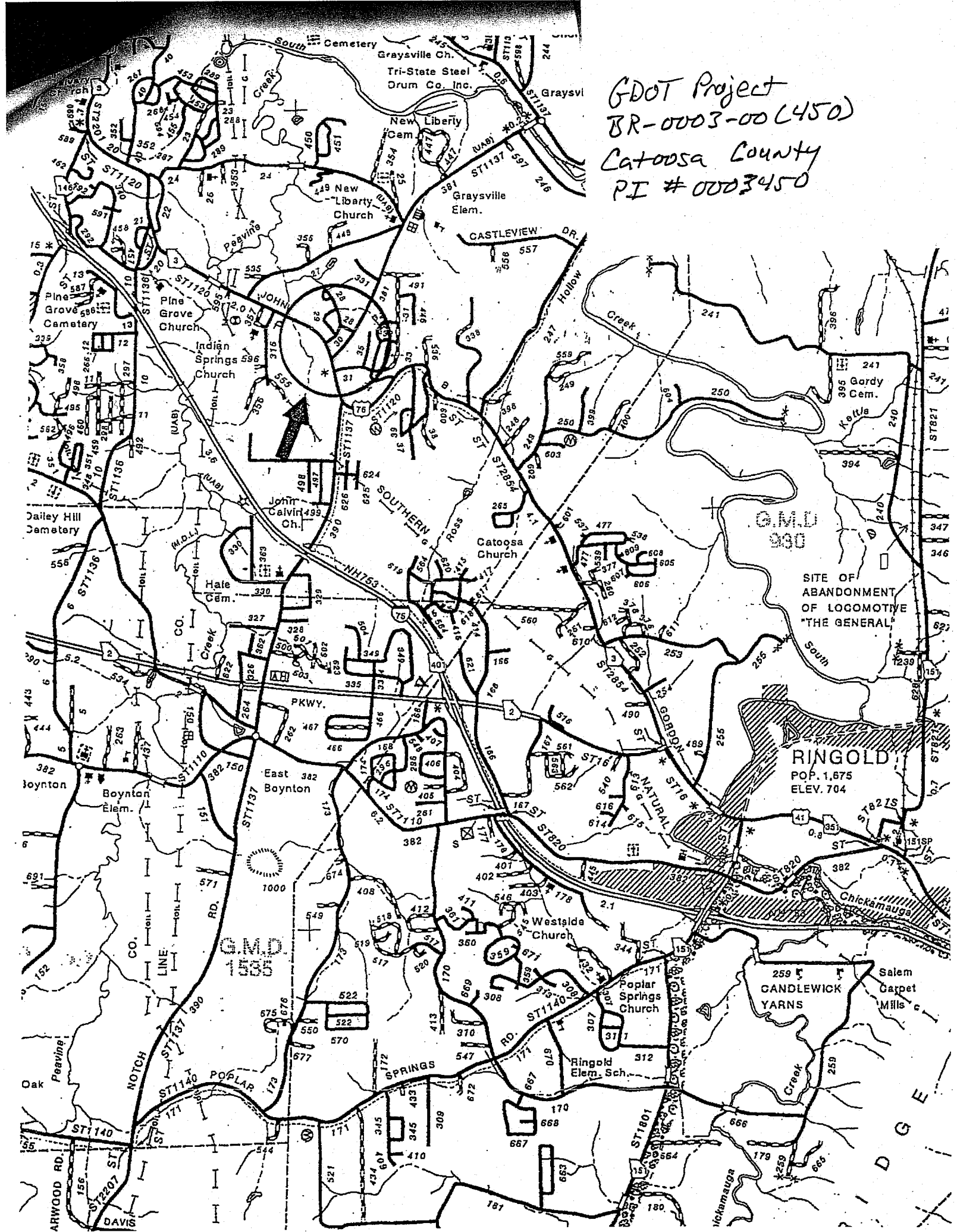
Project Description

STP-0003-00(948), Catoosa County, PI #0003948

US 41/SR 3/Dixie Highway at CR 381/Graysville Road Intersection Improvements

The proposed project would widen the existing two-lane US 41/SR 3/Dixie Highway to provide for left turn lanes at Judith Road, CR 381/Graysville Road, and CR 31/Indian Springs Road. The acquisition of right-of-way for the widening of US 41/SR 3/Dixie Highway would occur on both sides of the roadway, with widening occurring 6 feet symmetrically to provide the left turn lanes in the southbound direction. The roadway would be widened an additional 12 feet in the northbound direction to provide right turn lanes at CR 31/Indian Springs Road and CR 381/Graysville Road. The project would also widen the existing two 12-foot travel lane typical section of CR 381/Graysville Road for the addition of a left turn lane onto US 41/SR 3/Dixie Highway, where a traffic signal would be installed. Currently traffic on US 41/SR 3/Dixie Highway is a continuous flow movement; while traffic on CR 381/Graysville Road is controlled with a stop bar and stop sign.

The project along US 41/SR 3/Dixie Highway would begin approximately 426 feet south of its existing intersection with CR 31/Indian Springs Road and extend north approximately 1850 feet (0.35 mile), ending approximately 778 feet north of its existing intersection with Judith Road. On CR 381/Graysville Road, the project would begin at the existing intersection with US 41/SR 3/Dixie Highway and proceed east approximately 600 feet (0.11 mile).
