BLUE STAR DRIVE — DESIGNATED.

A RESOLUTION

THEREFORE, BE IT RESOLVED BY THE STATE HIGHWAY BOARD OF GEORGIA, that the portion of US-1, from the Georgia-South Carolina state line in Richmond County, through the cities of Augusta, Louisville, Swainsboro, and Waycross, to the Georgia-Florida state line in Charlton County, be designated as the Blue Star Drive.

BE IT FURTHER RESOLVED, that the State Highway Department of Georgia is authorized, empowered, and directed to place and maintain appropriate signs dedicating the road facility named in this Resolution.

BE IT FURTHER RESOLVED, that a copy of this Resolution be spread upon the minutes of this meeting.

BLUE STAR DRIVE — DESIGNATED.

A RESOLUTION

Designating the Blue Star Drive; and for other purposes.

WHEREAS, The Garden Club of Georgia is desirous of designating US-No. 1 in Georgia as Blue Star Drive to commemorate the services of her sons and daughters in time of war, and wishes to beautify the Blue Star Drive when so designated by planting shrubbery, establishing parks, picnic grounds and in other ways; and

WHEREAS, The National Council of Garden Clubs is sponsoring a nation-wide movement to establish such memorial drives, and, at its suggestion, many States have already accomplished this end by designating US-No. 1 within their limits as Blue Star Drive; and

WHEREAS, it is fitting and proper that such a dedication be made at this time.

THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF GEORGIA, that the portion of US-1, within the State of Georgia, be designated as the Blue Star Drive, as a memorial to the brave sons and daughters of this State who served her so valiantly in time of war.
