A RESOLUTION

1 Dedicating certain portions of the state highway system; and for other purposes.

2 **PART I**

16 greater than themselves, and it is abundantly fitting and proper that the outstanding
17 accomplishments and sacrifices of these remarkable and distinguished Americans be honored
18 appropriately.

20 WHEREAS, Herman E. Black was highly regarded by the citizens of the City of Gray and
21 by local government officials as a person of substance; and

22 WHEREAS, he was the son of William and Maggie Black, both pillars of the community;
23 and

24 WHEREAS, he spent 76 years of his life as a citizen of Jones County; and

25 WHEREAS, he was the father of four children, a husband, and a friend; and

26 WHEREAS, he gave a lifetime of service and commitment to his community by serving on
27 the Jones County Board of Equalization, was a founding member of the Jones County Men's
28 Club, and was a member of the Optimist Club; and

29 WHEREAS, it is fitting and proper to dedicate State Route 22 in the City of Gray from the
30 eastern city limit to its intersection with State Route 11 as the Herman E. Black Memorial
31 Highway as an appropriate tribute to this outstanding Georgian.

33 WHEREAS, Sgt. Carlton "Dan" Jenkins was shot and killed after making a traffic stop of a
34 robbery suspect on I-95 shortly after midnight on August 28, 2000; and

35 WHEREAS, Sgt. Jenkins had been with the Camden County Sheriff's Department for 7
36 years, and had been in law enforcement for 11 years; and

37 WHEREAS, the Camden County Sheriff's Department named him Officer of the Year in
38 1999; and

39 WHEREAS, in August of 2010, the 28th of August was declared to be Sergeant Carlton
40 Daniel Jenkins Day in Camden County; and

41 WHEREAS, he is survived by his wife and five children; and

42 WHEREAS, it is only fitting and proper that a permanent memorial to this outstanding
43 officer's life and service be established by dedicating an interchange on I-95 in his honor.

141 Patrol's 74 year history that an officer has received such an honor; and

142 WHEREAS, he was united in love and marriage to his supportive wife, Keisha Yearwood
143 LeCroy, and was blessed with two remarkable sons, Bret and Deaton; and

144 WHEREAS, he was the beloved son of Donna and Sam Houston and Bill and Tonya LeCroy,
145 son-in-law of Ken and Vicki Yearwood, and brother of Bill, Jamie, Jack, and Jake; and

146 WHEREAS, Trooper LeCroy loved sports, hunting, and spending time with his family and
147 friends; and

148 WHEREAS, he truly loved his career and law enforcement and wore his Georgia State Patrol
149 uniform with pride, exhibiting extraordinary devotion to duty, outstanding loyalty, fine
150 leadership, and meticulous attention to detail in all his duties, which were continually
151 recognized by his peers; and

152 WHEREAS, a compassionate and generous man, Trooper LeCroy will long be remembered
153 for his love of family and friendship, and this loyal husband, father, brother, uncle, and friend
154 will be missed by all who had the great fortune of knowing him.

206 blessed with a beautiful daughter, Lena; and

207 WHEREAS, Deputy Daniels exhibited extraordinary devotion to duty, outstanding loyalty,
208 fine leadership, and meticulous attention to detail in all his duties, which were continually
209 recognized by his peers; and

210 WHEREAS, a compassionate and generous man, Deputy Daniels will long be remembered
211 for his love of family and friendship, and this loyal husband, father, and friend will be missed
212 by all who had the great fortune of knowing him.

214 WHEREAS, Mr. Louie Clark was born November 25, 1924, in Mitchell County, Georgia,
215 and has spent his life serving others; and

216 WHEREAS, Mr. Clark served as a guardian of this nation's freedom and liberty with the
217 United States Navy from 1943 to 1946, was stationed aboard the destroyer USS *Haynsworth*,
218 and survived kamikaze attacks and numerous battles while defending the principles and

222 WHEREAS, Mr. Clark served on the Madison County School Board for several years before

234 WHEREAS, Mr. Bert Ward was born on May 30, 1922, in Catoosa County, Georgia, was
235 educated in the Catoosa County public school system, and graduated from Ringgold High
236 School; and

237 WHEREAS, Mr. Ward served as a guardian of this nation's freedom and liberty with the
238 United States Navy, valiantly and courageously protecting his fellow Americans during
239 World War II on the USS *Gillis* and the USS *Williamson* in the Pacific; and

249 elected to serve on the Board of Commissioners of Catoosa County; and

250 WHEREAS, as a member of the Board of Commissioners, Mr. Ward was instrumental in
251 establishing procedures, policies, and rules and regulations of the board and helped in the
252 establishment of the county's 911 emergency response system and the naming of the Catoosa
253 Parkway; and

254 WHEREAS, Mr. Ward's significant organizational and leadership talents, his remarkable
255 patience and diplomacy, his keen sense of vision, and his sensitivity to the needs of the
256 citizens of this state earned him the respect and admiration of his colleagues and associates;
257 and

258 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments and
259 service of this remarkable and distinguished Georgian be appropriately recognized.

260 **PART XIII**

261 WHEREAS, the Rev. Martin Luther King, Jr., stands as one of the most prominent
262 Georgians of the 20th Century; and

263 WHEREAS, Rev. King attended public school in Georgia, graduating from high school at
264 the age of 15, and received his bachelor's degree in 1948 from Morehouse College; and

265 WHEREAS, after three years of theological study at Crozer Theological Seminary in
266 Pennsylvania, where he was elected president of the senior class, he was awarded a divinity
267 degree in 1951, and, with a fellowship won at Crozer, he enrolled in graduate studies at
268 Boston University, completing his residence for the doctorate in 1953 and receiving his
269 doctoral degree in 1955; and

270 WHEREAS, in 1957, he was elected president of the Southern Christian Leadership
271 Conference, and, in the 11 years between 1957 and 1968, he traveled over 6 million miles
272 and spoke over 2,500 times in support of civil rights and wrote five books as well as
273 numerous articles; and

274 WHEREAS, he led a massive protest in Birmingham, Alabama, that caught the attention of
275 the entire world, providing what he called a coalition of conscience and inspiring his "Letter
276 from a Birmingham Jail," a manifesto of the Civil Rights Movement in the United States; and

277 WHEREAS, he also planned and participated in numerous protests and demonstrations for
278 the cause of civil rights including the peaceful march on Washington, D.C., of 250,000
279 people to whom he delivered his famous "I Have a Dream" address at the Lincoln Memorial;
280 and

281 WHEREAS, he was awarded five honorary degrees; was named Man of the Year by *Time*
282 magazine in 1963; and, at the age of 35, was the youngest man to have been awarded the
283 Nobel Peace Prize; and

284 WHEREAS, through his tireless work on behalf of civil rights for all people, he became not
285 only the symbolic leader of African Americans in the United States but also a world figure
286 in the fight for justice for all; and

287 WHEREAS, it is fitting and proper to dedicate the entire length of Snapfinger Road in
288 DeKalb County from its intersection with Wesley Chapel Road to the Henry County line as
289 the Martin Luther King, Jr., Parkway as an appropriate tribute to this outstanding Georgian.

290 **PART XIV**

291 WHEREAS, Roy Parrish was born in Walker County, Georgia, on November 29, 1933, one
292 of four children born to Roy E. Parrish, Sr., and the former Annie May Autry; the Parrish
293 family and the Autry family were pioneers to Walker County and have made this county their
294 homes since the eighteenth century; and

295 WHEREAS, Mr. Parrish was educated in the City of Chickamauga School System and
296 graduated from Gordon Lee High School in 1953; he started to work for the Chickamauga
297 Telephone Company while still in high school, and he remained in their employ for 19 years,
298 the last several as general manager; and

299 WHEREAS, he also served two years on active duty with the United States Army in Korea;
300 and

301 WHEREAS, he was elected Sole Commissioner of Walker County in the Democratic
302 Primary of 1972 and took office January 1, 1973; he went on to serve six, four-year terms;
303 and

304 WHEREAS, some of his major accomplishments include building the first sanitary landfill
305 in 1973 and operating it for 23 years; building and paving the county roads; passing the first
306 Local Option Sales Tax Referendum in 1977 that rolled back county property tax and for the
307 first time offered property tax relief to the local community; building the civic center,
308 pavilion, and the 911 Center; building a tunnel from the courthouse to the jail for security;
309 and building and operating an animal shelter, 16 fire stations, and 126 bridges; and

310 WHEREAS, Mr. Parrish worked with Georgia Department of Transportation and the United
311 States Department of the Interior as well as the National Park Service and Congressman
312 Buddy Darden to get a better corridor through or around the Chickamauga Battlefield and
313 was largely responsible for getting the western route through Walker County established as
314 the relocated Highway 27 around the Chickamauga National Park; and

315 WHEREAS, he has been married to the former Cora Ann Kell, also a native of Walker
316 County, for more than 50 years, and they have two children, two grandchildren, and two
317 great-grandchildren; they live in the City of Chickamauga where they are active members
318 of the Elizabeth Lee United Methodist Church; and

319 WHEREAS, he retired, undefeated, from public office in 1996 and now enjoys the freedom
320 of retirement; he and Cora Ann spend time traveling, enjoying their family, gardening, and
321 working in their church where Roy has recruited many of his friends; and

322 WHEREAS, it is only fitting and proper that a lasting tribute to this life of public service be
323 established.

(22) That the appropriate public roads and highways identified within Marietta, Atlanta, and Jonesboro by the Georgia Gone With the Wind Trail Committee with input from the appropriate county and municipal governing authorities be designated as the Georgia Gone With the Wind Trail;

(23) That the interchange of Interstate 185/State Route 411 with State Route 520/State Route 1 in Muscogee County is dedicated as the John Flournoy Interchange;

(24) That this body hereby joins in honoring the life and memory of Mr. Thomas R. "Tommie" Irvin and dedicates the intersection of Highway 441 and Apple Pie Ridge Road in Banks County as the Tommie Irvin Memorial Intersection;

(25) That Part XVI and the sixteenth undesignated paragraph of Part XIX of Senate Resolution 1075 (Ga. L. 2010, p. 362) are hereby repealed;

553 (26) That Part V and the fifth undesignated paragraph of Part XXVIII of House
554 Resolution 507 (Ga. L. 2011, p. 900) are hereby repealed;

555 (27) The Department of Transportation is authorized and directed to erect and maintain
556 appropriate signs dedicating the road facilities named in this resolution; and
